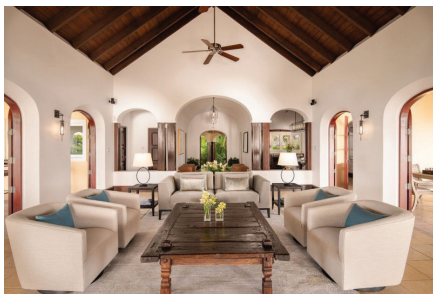
Northern Soul — In-Home Dinner with Celebrity Chefs

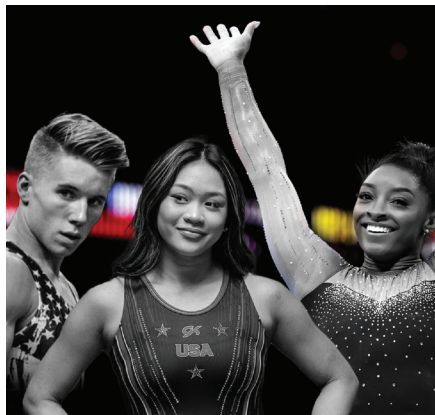
